

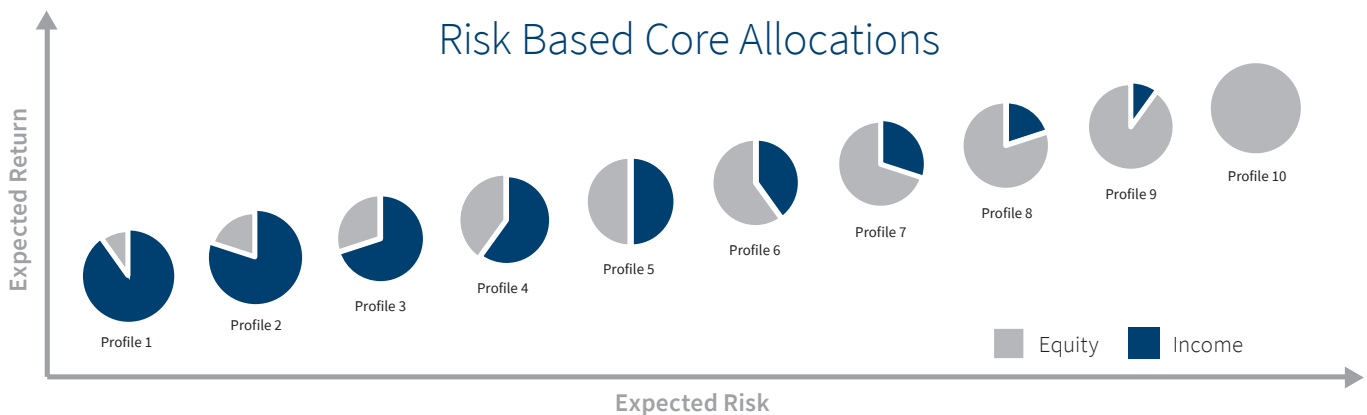


## Woods Wealth Management Core Platform

These strategies are designed to meet the needs of investors who want to minimize downside risk and we aim to accomplish this goal using systematic rebalancing that can help stabilize the portfolios and lower the overall volatility.

### Growth — Building Your Wealth

Profiles 6-10 span the Growth segment of the risk/return spectrum and these investors generally have a longer time horizon and are looking to accumulate wealth. These strategies are designed to meet the need of investors who can afford to recover from short-term losses in periods of high market volatility because goal fulfillment is many years or even decades down the road.
